(a) A person commits the offense of simple battery when he or she either: (1) Intentionally makes physical contact of an insulting or provoking nature with the person of another; or (2) Intentionally causes physical harm to another. (b) Except as provided in subsections (c) through (j) of this Code section, a person convicted of the offense of simple battery shall be punished as for a ...
