Solar batteries typically last 10-12 years at peak performance, but after this point they will start to decline considerably and need replacing. Companies typically reflect this fact in their warranties - as shown by AlphaESS's 10-year warranty on its SMILE-G3-S5 battery, or GivEnergy's 12-year warranty on the Giv-Bat 5.2.
