The Value range has a one year warranty, Plus with 2 years and Maxx with 3 years. Maxx also comes with a prorated warranty for 2 years, during which if your battery dies, you get a discount on your replacement battery and a new warranty as well. Walmart's car battery warranty claim is also a pretty easy process.
