Buying entities for the solar-generated power will set 2-hour periods each day during which energy will be drawn from the energy storage system (ESS), determined on a day-ahead basis.

Greenko Energies won the NTPC Renewable Energy's auction to set up interstate transmission system (ISTS)-connected energy storage systems of 3,000 MWh capacity with a minimum of 500 MW capacity to be installed anywhere across India..
